### Biden/Harris accomplishments in one year as of early 2022:

1. Passed the \$1.9 trillion American Rescue Plan
2. Passed the \$1.2 trillion Infrastructure Investment and Jobs Act
3. Regained more than 90 percent of the jobs lost in the early weeks of the pandemic.
4. Worked to increase wages an average of 5.6 percent over the past year.
5. Reformed the federal procurement process.
6. Released the first-ever United States Strategy on Countering Corruption.
7. Rejoined the Paris Agreement (also known as the Paris Climate Accord).
8. Created the first-ever National Strategy for Countering Domestic Terrorism.
9. Prioritized diversity for federal judges. Named the first Black woman to the Supreme Court.
10. Issued an Executive Order on Promoting Access to Voting
11. Issued an Executive Order repealing the prior administration’s harmful actions on workplace protections.
12. Signed an Executive Order requiring administration officials to take a stringent ethics pledge.
13. Reestablished the White House Office of Faith-Based and Neighborhood Partnerships.
14. Reinstated a policy to voluntarily disclose White House visitor logs.
15. Released their 2020 federal income tax returns, as well as their financial disclosure reports.
